## Warnings

This manual describes the general safety rules to be observed during any operation carried out with the Bead Changer. The procedures described in the following paragraphs must be carried out with respect to both the indicated execution methods and the general safety regulations. - Before use, check the expiration date of the product.
- Keep out of reach of children and animals. This product should only be used by adults.

## **Product Description**

The Bead Changer is made of two parts: a silicone tip and a biodegradable stick. The tip is shaped specifically to hold threaded balls or press fit balls inside the silicone tip to allow the piercer to more easily screw or attach the ball or gem to the other part of the jewelry already placed in the client's skin. This product is individually packaged and is neither a toy nor a medical device.

The product is intended to be used for aesthetic treatments by professional body piercers for the purpose of making piercings.

### **Residual Risks**

The manufacturing company has carried out an in-depth risk analysis on the product in question. #### **Conservation**

Before storing the product, check the condition of the packaging to ensure there are no traces of impacts, abrasions and/or traces of dirt, rust, mold, etc. which may have been caused by incorrect transport and/or storage. If so, notify the manufacturing company.

- Store the product inside a room-temperature, dry environment away from heat and sunlight.
- Product should remain inside its original packaging.

### Handling and unpacking

Remove the bead changer delicately from the pouch so as not to injure yourself or damage the product; dispose of the packaging according to local regulations. Product should only be removed from the sterile pouch immediately before use.

## Usage



The product is intended only for adults qualified as body piercers and should be kept away from children and animals.

The product is disposable. Do not use the product if the packaging is damaged before use.

NEVER use beyond the expiration date.

#### Usage procedure

- Sanitize your hands by washing them abundantly with soap and water.
- Wear protective gloves before handling the instrument and its packaging.
- To remove the bead changer, push the back of the bead changer out of the paper side of the pouch.
- Hold the stick firmly in hand and insert bead, gem, or ball that will be used in the aesthetic treatment.
- Insert into the proper piercing.
- Proceed with the aesthetic treatment.
