Product Description

Non-sterilized disposable plastic rings for simulating the positioning of the body piercing. Each ring is individually packaged and is sold in packs of 50 with assorted sizes. The product is neither a toy nor a medical device. Plastic rings for simulating the positioning of the body piercing. Non-sterilized disposable product. The rings are packaged in sachets of 50 pieces each with assorted sizes.

The product is intended to be used for aesthetic treatments by professional body piercers for the purpose of making piercings.

Residual Risks

The manufacturing company has carried out an in-depth risk analysis on the product in question. Conservation

Before storing the product, check the condition of the packaging, in particular that there are no traces of impacts, abrasions and/or traces of dirt, rust, mold, etc. which may have been caused by incorrect transport and/or storage. If so, notify the manufacturing company.

- Store the product inside a room-temperature, dry environment away from heat and sunlight.
- Product should remain inside its original packaging.

Handling and unpacking

Remove the rings delicately from the pouch so as not to injure yourself or damage the product; dispose of the packaging according to local regulations. Product should only be removed from the pouch immediately before use.

Usage



The product is intended only for adults qualified as body piercers and should be kept away from children and animals.

The product is disposable. Do not use the product if the packaging is damaged before use.

NEVER use beyond the expiration date.

Usage procedure

- Sanitize your hands by washing them abundantly with soap and water.
- Wear protective gloves before handling the instrument and its packaging.
- Select the appropriate size placement ring.
- Grasp the placement ring with the opening on the top.
- Open the slit enough to place on the skin that will be pierced.
- Adjust the placement ring to the appropriate placement.
- With a sterile marker, put a dot where the placement ring is touching the skin.
- Remove the placement ring and replace with the appropriate receptacle.
