General presentation

Before carrying out any operation with the product in question, ensure you have read the entire manual.

Stiletto does not recognize any documentation that has not been produced, released, or distributed by itself or by its authorized representative. This manual will be accessible online for an unspecified period of time and may be viewed by anyone. After this period, it will be the obligation and responsibility of those who manage the product to ensure that both the product and the documentation comply with the laws in play at the time of the inspection.

Warnings

This manual describes the general safety rules to be observed during any operation carried out with the piercing pack. The procedures described in the following paragraphs must be carried out with respect to both the indicated execution methods and the general safety regulations. Different countries may have different regulations regarding safety; in the case that the rules of the manuals conflict with the rules of the country in which the product is sold, the rules of the country will have priority over those of the manuals.

- When obtained, check the integrity of the product and its packaging to ensure it has remained in a sterile state. If you find any damage or trace of impacts due to transport, notify a Stiletto representative before proceeding with the subsequent operations. **NEVER USE DAMAGED PRODUCTS.**
- **Before use, check the expiration date of the product.**
- Keep out of reach of children and animals. This product should only be used by adults.
- Never use product in the mouth or nose for purposes other than those for which it is designed and used, i.e. creating a sterile field to pierce.

Product Description

The pack comes with 2 2 x 2 gauze pads, 1 3 x 3 gauze pad, 3 cotton swabs, 1 10% Povidone-Iodine Prep Pad, and 1 75% Ethyl Alcohol pad. The pouch, when open, will create a 14 inch by 4-inch sterile field for your aseptic technique to be performed on. The piercing pack with drape has the drape included as well. The product is neither a toy nor a medical device.

**The product is intended to be used for aesthetic treatments by professional body piercers for the purpose of cleaning the skin.

Residual Risks

The manufacturing company has carried out an in-depth risk analysis of the product in question. From this analysis, risks emerged that cannot be eliminated due to their nature, and the recommendations for how to avoid them were emphasized in the following manual. - Store this manual carefully as it is necessary for correct and safe use of the product.
- Always check the condition of the packaging and the expiration date before using a product.
- If the structure of the product presents deformations following an accidental impact that could presume it to be dangerous and/or unusable, replace the product.
- The product is intended to be used only by professional body piercers for creating a sterile field to pierce.

Conservation

Before storing the product, check the condition of the packaging to ensure there are no traces of impacts, abrasions and/or traces of dirt, rust, mold, etc. which may have been caused by incorrect transport and/or storage. If so, notify the manufacturing company.

- Store the product inside a room-temperature, dry environment away from heat and sunlight.
- Product should remain inside its original packaging.

Handling and unpacking

Open piercing pack from the flap on the side to retrieve all the prepackaged and sterilized supplies contained within. Open each sterile pouch as needed; dispose of the packaging according to local regulations. Product should only be removed from the sterile pouch immediately before use.

Usage



The product is intended only for adults qualified as body piercers and should be kept away from children and animals.

The product is disposable. Do not use the product if the packaging is damaged before use.

NEVER use beyond the expiration date.

Usage procedure

- Sanitize your hands by washing them abundantly with soap and water.
- Wear protective gloves before handling the instrument and its packaging.
- Lay a bib across tray, and do not place piercing tools directly onto the bib.
- Remove the products contained in the piercing pack as necessary to create a sterile field for cleaning the skin.
- Proceed with the aesthetic treatment.
